Jeanette McBride discussed The Foundation Fund Statement as of March 31, 2024, is showing a total fund balance for all three funds of \$4,969,035.30. This reflects a market increase for March 2024 of \$83,599.57. The current balance surpasses the all-time high of funds set in 2021 when the balance almost reached \$5,000,000.

Mrs. McBride stated that the Endowed Funds Quarterly Report shows the details of activity in the Wells Fargo account for the months of January through March 2024. There were two new scholarships established that were mentioned at the last meeting; the Melvin Forbes Next Generation Scholarship funded at \$20,000 and the Gail Gallimore Endowed Scholarship funded at \$15,000.

Mrs. McBride shared the STIF Quarterly Report showing the details of activity in the State Treasury account for the

months of January through March 2024. These funds are temporary restricted funds. The ending balance for all STIF funds totals \$258,345.73.

### 8. Foundation Report - Korrie Ervin

### 8.1 <u>2023-2024 Budget Review</u> *∅*

Korrie Ervin reported that The 2023-2024 Foundation Budget is mostly in line with anticipated expenditures. There are a few large items awaiting an invoice, one of which is the annual audit that was presented at the last meeting.

Mrs. Ervin informed the Board that the Sandra Miller High School Student Assistance Fund has an annual budget of \$5,000 and this will be close to reaching \$6000 by the end of the year. These funds cover any extra expenses a high school student may have while attending MCC. The most costly of these is in the medical programs including background checks and student exam fees. As this program for high school students continues to grow, the Foundation will need to consider increasing this budget in the coming years.

Mrs. Ervin stated that the Foundation just received a donation from First Health which can be used to cover medical student fees for a couple of years.

# 8.2 <u>2024-2025 Proposed Budget</u> @

Korrie Ervin discussed the proposed budget for 2024-2025 is based on the same anticipated income from the Golf Tournament, Fall Fundraiser, and Shooting Tournament with a total of \$65,000 annual budget.

Mrs. Ervin stated that there will be a request for an adjustment to the RFP Audit.

Dr. Bledsoe discussed the Professional Development amount being changed to a cash payment for the employee chosen as employee of the year. (Faculty and Staff)
