### Advanced Placement LPN to RN

The Advanced Placement LPN to RN program begins during the 2<sup>nd</sup> eight weeks of the spring semester of each academic year.

#### **Documentation Required:**

All elective courses must be completed prior to acceptance into LPN to ADN program. These include BIO 275, PSY 241, ENG 112, Humanities/Fine Arts-ART 111, HUM 115, MUS 110, PHI 215 and PHI 240. BIOs must have a grade of B if taken after the fall 2017. Must have completed at least high school level chemistry and algebra.

<u>All admissions as an LPN with advanced standing are made on a space available basis.</u> Admission is not automatic for LPNs with advanced standing. Determination of available space is made by considering the number of students that can be accommodated by the availability of spaces in the program. **Applications due October 31.** 

#### Applicants must complete the most recent version of the TEAS test for acceptance consideration.

Advanced option students must meet the same admission requirements as traditional LPN and ADN nursing applicants- using the Reinforced Instruction for Student Excellence (RISE) placement model, be eligible to enroll in ENG 111 and MAT 143 WITHOUT a co-requisite for the nursing program by the admissions deadline. See placement options below. It is the student's responsibility to ensure documentation of appropriate test scores, or course completion is received by the Admissions Office by the deadline.

Be eligible to enroll in ENG 111 and MAT 143 without a co-requisite by completing or receiving:

#### ENGLISH

- Transfer credit for ENG 111; or
- Waiver credit for all of the following: DRE 096, DRE 097, DRE 098; or
- Waiver credit for ENG 002 with a minimum grade of P2; or
- Waiver credit for ENG 011

#### MATH

- Transfer credit for one of the following- MAT 140, MAT 143, MAT 152, MAT 171 (or higher-level math); or
- Waiver credit for all of the following- DMA 010, DMA 020, DMA 030, DMA 040, and DMA 050; or
- Waiver credit for MAT 003 with a minimum grade of P2; or

• Waiver credit for one of the following: MAT 043, MAT 052, or MAT 071

Students must complete the LPN verification attestation form. **Completion of this form verifies that the applicant has completed a minimum of one-year, full-time (or equivalent length of part-time) work experience in an LPN role within the last three years.** 

Licensed Practical Nurses must be a graduate from an approved PNE program. PNE program transcript must show a minimum grade point average of 2.5 with no less than a "C" in any course.

Health report including immunization record completed by a physician, nurse practitioner or physician's assistant. The form must be current, using the form supplied by the college. The following immunizations are required:

- 1. DPT, DTAP in last 10 years, 2 Mumps, Rubella (MMR) or titer: 2 varicella (chickenpox) or titer and 2 step Tuberculin skin test or chest X-Ray.
- 2. Immunization for Hepatitis B is recommended but a declination form can be signed.
- 3. Influenza Vaccine.

#### Medical forms are due back February 1<sup>st</sup> to the Director of Nursing.

#### **IMPORTANT TO REMEMBER:**

- Current certification in Cardiopulmonary Resuscitation (CPR); must be maintained through the **American Heart Association.**
- Students must maintain licensure as an LPN during program enrollment.
- Criminal Background/Drug Screen Checks:

Affiliating agencies used by MCC's ADN program require students to submit to criminal background checks, drug testing and/or health screening prior to or during participation in class, lab, clinical or co-op experiences at their sites. Students should be aware that progress toward graduation may be limited by any inability to meet the agency requirements for student placement.
