Admission into Dental Assisting (DA II)

Admission to the Dental Assisting program is based on completion of all the following requirements including appropriate academic assessment outcomes. It is the student's responsibility to ensure that documentation of testing and/or courses completed is transmitted to the Admissions Office. Prospective students are not considered for admission until all paperwork and all assessment benchmarks are complete and verified through the Admissions Office.

Admission Requirements & Application Deadline: April 15

- > Apply: Complete NC residency determination at www.mcresidency.org before applying online at www.montgomery.edu by April 15.
- > Request transcripts: Submit a high school/high school equivalency certificate (GED®)/Adult High School transcript that meets North Carolina standard and any necessary college transcripts. (MCC reserves the right to test for proficiency any applicant asking for transfer credit on theory or clinical course.)
- ➤ **Biology Competency:** Completion of a high school or college biology course with a grade of "C" or higher taken within the past ten years. If BIO 106 or its equivalent is the course taken, the course must be completed within 3 years of acceptance in the dental program with a grade of "B" or higher in order for transfer credit to be awarded.
- > **Placement**: Using the Reinforced Instruction for Student Excellence (RISE) placement model be eligible to enroll in ENG 111 and MAT 110 WITHOUT a co-requisite for the Dental Assisting program by April 15. See Placement options below. It is the student's responsibility to ensure documentation of course completion is received by the Admissions Office by the deadline.

Points Selection Process

After the application deadline, a point selection process will be used to rank qualified applicants for acceptance into the program. The selection process will be for those applicants who have completed all the Admissions Requirements. **Information on the ranking process is included with this guide.** The point selection process will be completed in late April and applicants will be notified about acceptance or placement on an alternate list by mail mid-May.

Provisional Acceptance

After all criteria for admission and ranking has been satisfactorily completed, applicants will be evaluated for provisional acceptance. A point selection process will be used to rank applicants for acceptance into the program. Applicants will receive written notification from the Admissions Office concerning provisional acceptance or placement on the Dental Assisting alternate list. Acceptance is provisional pending the following requirements.

- Orientations: Attendance is required at the mandatory orientation session. Many aspects of the program will be discussed and include, but not limited to tuition, books, schedules, program expectations for class, lab and clinical. Failure to attend could result in forfeiture of position in the program.
- > CPR: Be certified with Basic Life Support CPR prior to registration and must be maintained throughout enrollment. No fully online certification will be accepted. Documentation must be submitted to the Admissions Office prior to registration.
- Medical form: Completion of student medical form and evidence of physical and emotional health requirements necessary to provide safe dental care. Qualified applicants will be provided the medical form at the mandatory orientation. The completed form must be returned by the designated due date or the provisional acceptance will be forfeited. The Applicant Medical Form will be reviewed by the Dental Assisting Department Head and must be approved before the applicant can register. Due to the nature of the dental assisting profession, students must have the physical ability to bend, sit and stand for sustained periods. In addition, the student must have hearing ability and visual acuity to determine accuracy, neatness, and thoroughness of work and demonstrate manual dexterity. Standard technical skills can be found on the program website.
- ➤ Background/drug screen checks: Affiliating agencies used by MCC's Dental Assisting program require students to submit to criminal background checks, drug testing and/or health screening prior to or during participation in class, lab or clinical experiences at their sites. Students should be aware that progress toward graduation may be limited by any inability to meet the agency requirements for student placement. Any required testing or documents needed will be at the expense of the student.

Academic Requirements

Dental Assisting students are required to maintain at least a

2.0 GPA (a "C" average) to remain in the program with a grade of "B" or better in each DEN course and BIO 106 or equivalent course(s).

In addition, students are required to successfully complete an **Instrument ID** test at a score of 86 or higher to remain in DEN 101 Preclinical Procedures. A student dropped from DEN 101 due to not meeting this requirement, **cannot** progress into the spring semester. If a student is accepted into the program a second time, they will be required to repeat **ALL DEN** courses regardless of a passing grade in a specific course(s) during a previous academic year.

Applicants for Readmission

Readmission to the Dental Assisting program is based on successful completion of the requirements for readmission and space availability. A student may be admitted to the Dental Assisting program only twice, including re-instatement.

Reapplication for Subsequent School Terms

If an applicant is not accepted into the program or is accepted but decides not to attend and wishes for their application to be considered for another academic year, they must reapply for admission by completing a new application. Previous files will not be considered for admission. Applicants should reapply as soon as possible or by April 15 for the next school year.

Transfer Applicants

Positions are sometimes available for students from other Dental Assisting programs. All students applying for transfer to MCC should complete the application process by October 1. Any transfer credits must be a grade of "B" or above and be evaluated by Student Services and Dental Assisting faculty prior to entrance. The College reserves the right to test any applicants requesting transfer credit on any theory or clinical course.

Gen-Ed Courses

Prior to acceptance into the Dental Assisting program, applicants may enroll in required Gen Ed courses. By completing these courses ahead of time, the course load in dental assisting the following year will be reduced. However, completing Gen-Ed courses may affect financial aid awards. Applicants should consult with the financial aid staff for more information.

Being enrolled in these related classes, however *does not guarantee a position* in the Dental Assisting class for the new academic year. Each applicant will still have to compete for the available positions using the regular dental assisting admissions criteria. Applicants who have completed related courses at other institutions should contact the Registrar's Office at MCC concerning their transferability. Due to course content, related courses must have been completed within the last three (3) years with a grade "C" or higher in ENG 111 and PSY 150 and a grade of "B" or higher in BIO 106. *This includes credits earned at MCC as well as other post-secondary institutions*.

Statement of Good Standing

If a student has been dismissed from a previous Health Science Program, they must submit a "Statement of Good Standing" prior to enrolling in the Dental Assisting Program

IMPORTANT NOTE TO APPLICANTS:

Infection control guidelines for the Dental Assisting program have been developed to protect the student and the patient from disease transmission and are articulated in specific program courses. Students will have the knowledge and skill to deliver patient care safely through classroom instruction and laboratory experiences. A student in the program is at an increased risk for exposure to a variety of diseases including Hepatitis C, HIV/AIDS, and tuberculosis. Because of these risks, students are expected to follow all infection/hazard control guidelines that have been established within the program and other infection control agencies.

The components of the ranking system include the following. It is the student's responsibility to ensure documentation is on file in the Admissions Office.

Academic Points

Academic Points are awarded for grades in the following course or approved substitutions. Only those courses completed by the deadline will be used for ranking. Due to course workload, students are strongly encouraged to complete the general education courses before entering the Dental Assisting program.
