

**CLASS/REGISTRATION SCHEDULE:**

- ▶ Reading Assessment **See Director of BLET to schedule a testing date.**  
The reading assessment is **required for all BLET students.**  
(Test time is approximately 45 minutes.)
- ▶ **Registration** **June 1, 2023 – August 31, 2023**
- ▶ **Classes Begin** **September 5, 2023** **5:30pm**
- ▶ Class Schedule **Monday through Friday** **5:30 pm - 11:00 pm**  
**(Some Saturdays 8:00am – 8:00pm)**
- ▶ Last Day of Class April 14, 2024 (Date Subject To Change)

**BLET ENROLLMENT REQUIREMENTS:**

**You are required to schedule and meet with the BLET Director prior to enrollment.  
Contact Jeff Dorsett, Director of BLET at 910-898-9710 for an appointment.**

- ▶ You must be a U.S. citizen.
- ▶ You must be at least **20 years old** before April 2024.
- ▶ You must have graduated from an accredited high school or successfully completed the GED; a copy of your transcript must be on file in the Admissions Office at MCC.
- ▶ **You must have a certified copy of your criminal history report for all counties & states in which you have resided since the age of 18; the report(s) must be approved prior to enrolling in BLET. You may not have a felony conviction; if you are concerned about your criminal history, please contact the BLET School Director, Jeff Dorsett. (Some misdemeanor offenses also apply.) Students are provisionally accepted pending approval of the report(s).**
- ▶ You must have a physical examination form and exposure form completed by a doctor; the form must be included with the completed application packet.
- ▶ **All individuals are required to establish a sponsorship agreement before entering BLET at Montgomery Community College. All sponsorship letters must be submitted in completed application packets and remain valid throughout the program's entirety.**
- ▶ You must have a valid driver's license.
- ▶ You must complete the Reading Assessment exam.

**NOTE: Your Reading Assessment score must indicate a minimum of a 10<sup>th</sup> grade level for acceptance into the program.**
